**VENDOR GUIDELINES FOR Tuesday Morning Fresh Market**

- . The Gulfport Merchants Association (GMA) and the City of Gulfport will provide a 10x10 space.
- . Vendors will provide their own canopy, tables, chairs, extension cords, display, etc...
- . The Gulfport Merchants Association will provide power.
- . Vendors are responsible for their own property.
- . Cooperation with local authorities is mandatory.
- . Only one vendor per space is allowed.
- . Only ready to eat foods will be permitted at Tuesday Morning Fresh Market.
- . The following items are prohibited for sale at Tuesday Morning Fresh Market: Fire Arms, Alcohol, Obscene Merchandise, and Illegal paraphernalia.
- . Entertainers must adhere to the decibal noise level, and safety will be monitored.
- . Vendor Identification (Provided by GMA) must be clearly visible and will show the name of the vendor and vendor number.
- . Initial set up is at 8 am. Please Unload Supplies and move your car to the Library or Shore Blvd. beach parking areas and then set up.
- . Vendors are responsible for collecting and reporting their own SALES TAX.
- . Vendors must **SIGN A WAIVER OF LIABILITY.**
- . All fees must be paid in full prior to the event.
- . There will be no refunds due to any show, bad weather, cancellation, etc.
